SikaGrind® SW 4345 is a composition of hydroxyl containing organic chemicals, polyamine and excited carboxylate base formulated specifically to improve the milling grindability and cement quality performance for the production of portland and other hydraulic cement types. High end raw materials are used in order to guarantee a superior performance of the product.

USES

SikaGrind® SW 4345 is highly recommended for use on both the horizontal ball mill and vertical roller mill applications. The enhancing effect towards the cement quality is due to the promoted hydration reaction phase, better workability rheology and improved Particle Size Distribution structure.
